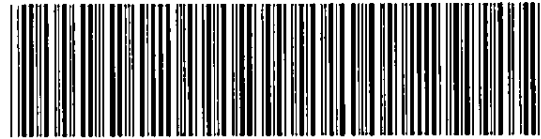

FIRST: This Amended Restated Articles of Organization amends and restates the Articles of Organization of Sound House Studios, LLC.
