**AMENDED AND RESTATED
ARTICLES OF ORGANIZATION
FOR
DAILY CONVO, LLC**

The undersigned, representing all of the members of DAILY CONVO, LLC, a Florida limited liability company (the "Company"), hereby present these Amended and Restated Articles of Organization pursuant to the provisions of Section 608.411, Florida Statutes. These Amended and Restated Articles of Organization have been duly adopted by all of the members of the Company.

FIRST: The Company's Articles of Organization were filed on June 11, 2013, with the Florida Department of State and assigned document number L13000084432.

SECOND: The Articles of Organization are superseded in their entirety by the provisions of these Amended and Restated Articles of Organization.

THIRD: The Company's Amended and Restated Articles of Organization are set forth in their entirety as follows:

ARTICLE I - NAME

The name of the limited liability company is:

This limited liability company is referred to in these Amended and Restated Articles of Organization as the "Company."

ARTICLE III - PURPOSES AND POWERS


ARTICLE VII - AMENDMENT


