ARTICLES OF ORGANIZATION FOR GloxiniaLife, LLC

ARTICLE 1 - NAME

The name of the Limited Liability Company is GloxiniaLife, LLC

ARTICLE II - ADDRESS

The malling address and street address of the principal office of the Limited Liability Company is 17120 Royal Palm Boulevard, Suite 4, Weston, FL 33326.

ARTICLE VI - ADMISSION OF ADDITIONAL MEMBERS

The Members of the Limited Liability Company shall have the right to withdraw as a member with (i) six (6) months prior notice, and (ii) with the consent of Members owning at least ninety (90%) percent of the Member Units of the Limited Liability Company. Likewise, there shall be no return of all or a portion of the contributed capital without the consent of Members owning at least ninety (90%) percent of the Member Units of the Limited Liability Company.

ARTICLE IX - DISTRIBUTION

The purpose of the Limited Liability Company is to engage in one or more businesses and/or to invest and reinvest its assets. Accordingly, no distribution is contemplated. Notwithstanding the foregoing, the Board of Managers and Members owning at least ninety (90%) percent of the Member Units of the Limited Liability Company may consent to a distribution. All distributions shall be in the form of insurance company annuity contracts with the respective member as the annuitant, unless the Board of Managers and Members owning at least ninety (90%) percent of the Member Units of the Limited Liability Company consent otherwise.
