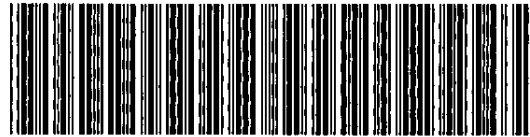


Dear Ms. Cushing:


