**ARTICLE I

All of the remaining property and assets of the Company shall be distributed to the Members of the Company in accordance with the proportion of Membership Units owned by them as reflected in the Operating Agreement of the Company.

To the knowledge of the member of the Company, there are no suits pending against the Company in any court.
