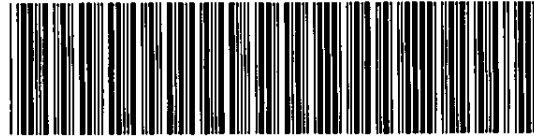

**ARTICLES OF AMENDMENT  
TO ARTICLES OF ORGANIZATION OF**

**PDQ JACKSONVILLE – BARTRAM PARK PROPCO, LLC**

**THE UNDERSIGNED** hereby executes and swears to these Articles of Amendment to Articles of Organization of PDQ JACKSONVILLE – BARTRAM PARK PROPCO, LLC, a Florida limited liability company (the “Company”), pursuant to the Florida Limited Liability Company Act, as amended, Florida Statutes § 608.411:

1. **Name of Company.** The name of the Company is PDQ JACKSONVILLE – BARTRAM PARK PROPCO, LLC.

2. **Date of Filing of Articles of Organization.** The Company filed with the Florida Department of State Articles of Organization effective June 17, 2013 (the “Articles”).

3. **Amendment to Articles of Organization.** The first paragraph of the Company’s Articles is hereby amended by deleting the current text in its entirety and substituting the following in lieu thereof:

*“1. Name. The name of this limited liability company is MVP H<sup>2</sup> Jacksonville – Bartram Park Propco, LLC (the “Company”), and it shall be formed as a limited liability company under Chapter 608 of the laws of the State of Florida.”*
