The undersigned, Stuart Reeves, a natural person competent to contract and a member of GulfStream Shipbuilding, LLC, hereby presents these Articles of Organization as the Articles of Organization of GulfStream Shipbuilding, LLC, a limited liability company formed under the provisions of Chapter 608, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is GulfStream Shipbuilding, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

The street address and mailing address of the Company's initial principal office is 16 Shipyard Road, Freeport, Florida 32439. The Company's principal office may hereafter be at such other place or places as its member from time to time may determine.

ARTICLE III - PURPOSES AND POWERS

The Company shall have all powers and rights which a limited liability company may exercise under the Florida Limited Liability Company Act, Chapter 608, *Florida Statutes*, as such chapter presently exists and may hereafter be amended.

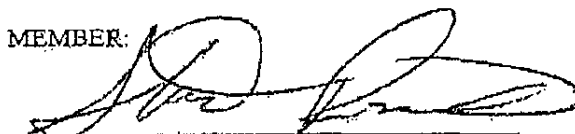
ARTICLE VI - MANAGEMENT
