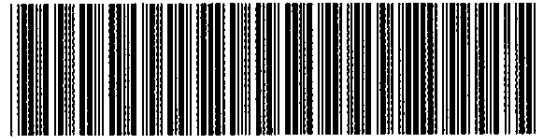

**ARTICLES OF ORGANIZATION**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

**ARTICLE I -- NAME**

The name of the limited liability company shall be **ARG MORTGAGE, LLC, (Company)**.

**ARTICLE II -- ADDRESS**

The mailing address and street address of the principal office of the company is 110 Spoonbill Road, Manalapan, FL 33462.

**ARTICLE III -- DURATION**

A member may transfer his or her interest in the company as set forth in the regulations of the company, but the transferee shall have no right to participate in the management of the business and affairs of the company or become a member unless

**ARTICLE VI-- MEMBERS' RIGHT TO CONTINUE BUSINESS**


