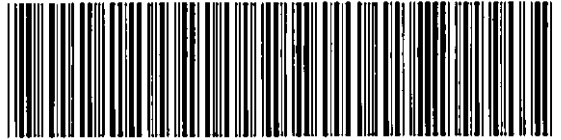

FIRST: This Amended Restated Articles of Organization amends and restates the Articles of Organization of GULF COAST INDUSTRIAL MAINTENANCE, LLC.

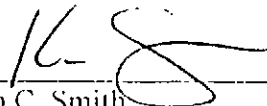

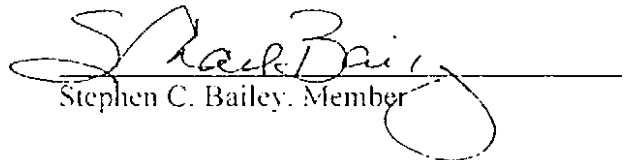
