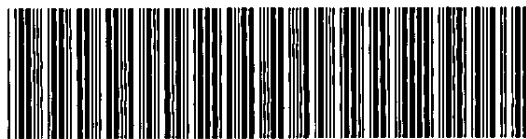

The mailing address and the street address of the principal office of the Company is 8489 Cabin Hill Road, Tallahassee, Florida 32311.

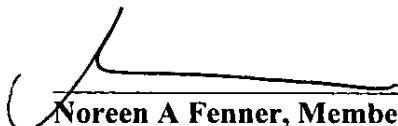
**ARTICLE III- REGISTERED OFFICE AND AGENT**

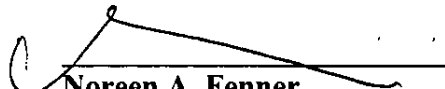
