ARTICLE I -- NAME

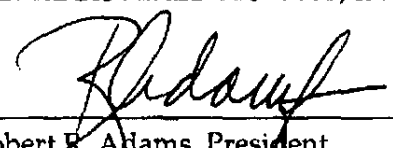
