**ARTICLE VI**

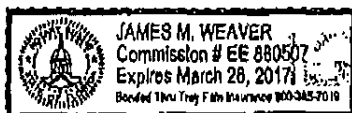

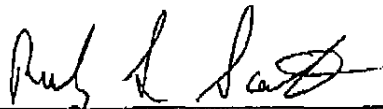
