**ARTICLES OF ORGANIZATION
OF

THE UNDERSIGNED hereby certifies that I intend to form a limited liability company under the laws of the State of Florida, and hereby declares that the following Articles shall be the Charter and authority for the conduct of business of such limited liability company.

**ARTICLE I
NAME**

The name of the limited liability company (the "Company") shall be **DG FLORIDA ENTERPRISES, LLC**

**ARTICLE II
ADDRESS**

The general nature of the business or businesses to be transacted and which the company is authorized to transact shall be as follows:

- B. In general, to carry on any and all incidental business; to have and exercise all the powers conferred by the laws of the state of Florida, and to do any and all things herein set forth to the same extent as a natural person might or could do.

The existing members shall determine the amount and nature of the contribution by new members at the time the new members are admitted.

ARTICLE VIII CONTINUATION OF BUSINESS OPERATIONS

The Company may continue its business operations upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in a limited liability Company only upon the unanimous approval of the remaining members, unless otherwise provided in the Company's Operating Agreement.

A member's interest in the Company shall not be transferred unless the transfer is approved by the members in accordance with the Company's Regulations.




