**ARTICLES OF AMENDMENT TO
ARTICLES OF ORGANIZATION OF

NOW, THEREFORE, as the Manager and all of the Members of the Company, the undersigned hereby amend the Articles as follows:


1. Article IV, "Management," of the Articles of Organization of the Company is hereby amended to read as follows:


**"ARTICLE IV
MANAGEMENT**
