ARTICLES OF ORGANIZATION OF SYNERGY CAPITAL PARTNERS OF CENTRAL FLORIDA, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Act, F.S. Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company (the "Company") shall be SYNERGY CAPITAL PARTNERS OF CENTRAL FLORIDA, LLC.

ARTICLE II - DURATION

The limited liability company shall have perpetual duration.

The power to adopt, after, amend or repeal the Operating Agreement shall be vested in the Members of the Company by unanimous written consent.
