SECOND AMENDMENT TO ARTICLES OF ORGANIZATION**

**THIS SECOND AMENDMENT TO ARTICLES OF ORGANIZATION** (the "Amendment") is made and entered into and effective as of this 1 day of June, 2017, for **Living Care Solutions LLC, a Florida limited liability company** (the "Company") (Document Number L13000092387) by and between Miriam Alonso ("Alonso"), Fernando Espino ("Espino"), Aracelys Roque ("Roque"), Margarita F. Garcia, as Manager of MMG Pinecrest Investments, LLC, a Delaware limited liability company ("MMG Pinecrest") (individually and collectively the Assignors") and Alain J. Hernandez ("Hernandez"), Lonnie Steckler ("Steckler"), and Manuel J. Vadillo ("Vadillo") (individually and collectively the "Assignees").

**RECITALS:**

**WHEREAS**, the Articles of Organization were filed with the State of Florida on June 27, 2013 and subsequently amended by that certain Articles of Amendment to Articles of Organization on December 17, 2013 ;

**WHEREAS**, Alonso owns Fourteen percent (14%) of the Membership Interest in the Company and is a Manager of the Company; Espino owns Twenty-four percent (24%) of the Membership Interest in the Company and is a Manager of the Company; Roque owns Twenty percent (20%) of the Membership Interest in the Company is a Manager of the Company; and MMG Pinecrest owns Forty-two percent (42%) of the Membership Interest in the Company and is a Manager.

**WHEREAS**, Assignors desire to transfer all of individual their rights, title, and interests in the Company to Hernandez as it pertains to Sixty-five percent (65%) of the Membership Interest in the Company, Steckler as it pertains to Thirty percent (30%) of the Membership Interest in the Company and Vadillo as it pertains to a Five percent (5%) of the Membership Interest in the Company.

**WHEREAS**, a meeting was held on May 31, 2017, at which time all persons having interest in the Company were present.

**NOW THEREFORE**, in consideration of Ten 00/100 Dollars (\$10.00), the covenants and the promises made herein, and other good and valuable consideration the receipt of which is hereby acknowledged, the parties hereby agree as follows:

1. The recitals hereto are true and correct and incorporated hereto by reference.
2. All capitalized terms herein shall have the same definitions as set forth in the Agreement unless otherwise noted.
3. Article V of the Articles of Organization shall be amended as follows:

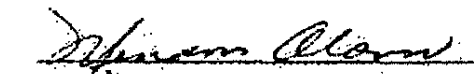

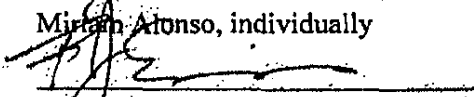
4. That the Assignors, individually and collectively, hereby resign as Managers of the Company as evidenced by Exhibit "A" of this Agreement.

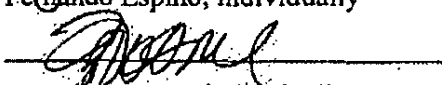
5. The Effective Date of this Agreement shall be June 1, 2017.

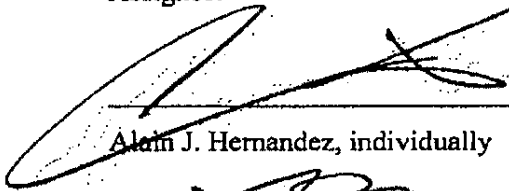

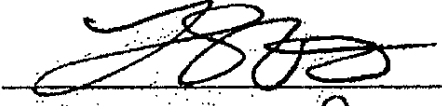
