**ARTICLES OF ORGANIZATION

ARTICLE V (REGISTERED AGENT)

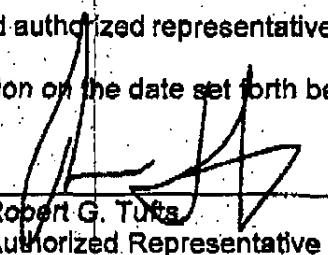

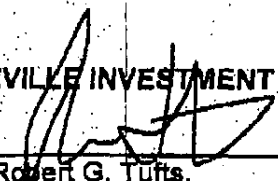

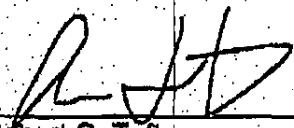
