ARTICLES OF AMENDMENT TO  
ARTICLES OF ORGANIZATION OF

Pursuant to Section 605.0202 of the Florida Statutes, the Articles of Organization of THE SURGICALIST COMPANY, LLC, a Florida limited liability company (the "Company"), are hereby amended as follows:
