**AMENDED AND RESTATED
ARTICLES OF ORGANIZATION**

The undersigned, desiring to amend and restate the Articles of Organization of Tolomato CDD Holdings, LLC originally filed on June 27, 2013 (the "Company"), for the purpose of changing the name of the Company and making certain other amendments set forth herein, under and pursuant to the Florida Limited Liability Company Act, Chapter 608.411, Florida Statutes, does hereby adopt the following Amended and Restated Articles of Organization:

**ARTICLE I
NAME**

The name of the Company is changed to FBCJAX Holdings, LLC.

**ARTICLE II
ADDRESS**

The mailing address and street address of the principal place of business of the Company is:

**ARTICLE III
REGISTERED AGENT AND OFFICE**

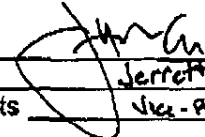
**ARTICLE IV
PURPOSE**

The Company is formed exclusively for charitable, religious, educational and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(C)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. Subject to the foregoing, the Company may undertake such activities as are approved by the Member and engage in any lawful act or activities necessary or incidental thereto, so long as the Company shall not carry on any activities not permitted to be carried on (a) by an organization exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code or corresponding section of any future federal tax code. No substantial part of the activities of the Company shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Company shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. The Company may not merge with, or convert into, a for-profit entity.

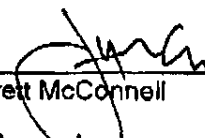
