ARTICLE IV

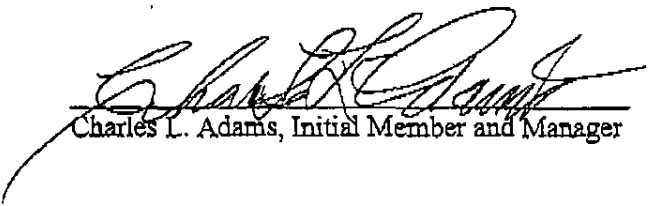
MANAGEMENT OF COMPANY BUSINESS
