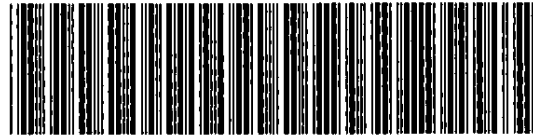



ARTICLE I - NAME

THE NAME OF THIS Limited Liability Company shall be **RPCK PROPERTY MANAGEMENT, LLC.**

ARTICLE II - ADDRESS

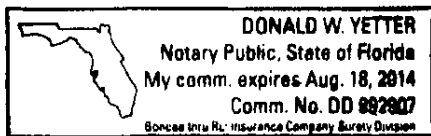
