# ARTICLES OF ORGANIZATION OF WEARING IS CARING, LLC

The undersigned subscriber to these Articles of Organization, a natural person competent to contract, does hereby form a limited liability company under the laws of the State of Florida.

### ARTICLE I

The name of the limited liability company shall be WEARING IS CARING, LLC.

### ARTICLE II Address and Place of Business

### ARTICLE III Period of Duration
