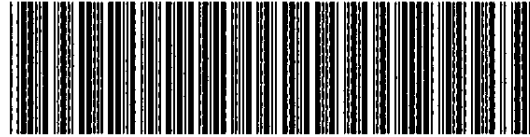

**ARTICLES OF ORGANIZATION FOR**

**ARTICLE I**  
**NAME**

The name of the Limited Liability Company is: **Cows R Out!, LLC.**

**Article II**  
**ADDRESS**

The mailing address of the Limited Liability Company is 328 Brookhaven Place, Lake Mary, FL. 32746. The street address of the principal office of the Limited Liability Company is 328 Brookhaven Place, Lake Mary, FL. 32746. These addresses may be changed from time to time.

**ARTICLE III**  
**DURATION**

The period of duration for the Limited Liability Company shall be perpetual, unless earlier terminated under the Act or the Operating Agreement.

**ARTICLE IV**  
**PURPOSE**

The Limited Liability Company is anticipated to be a start-up umbrella organization that will at some time in the future potentially have up to three divisions. The potential divisions, should same occur, would be categorized generally as: 1) book and audio publishing, 2) self-expression card publishing, and 3) gift items. The decision and timing of which divisions are actually set up, organized, developed and become functioning divisions of the Company rests solely with the managing members of the Company.

Additionally, or in lieu thereof, the Limited Liability Company may engage in any activity permitted under the laws of the United States or the Laws of the State of Florida. The Limited Liability Company is specifically authorized to conduct any and all lawful business permitted by the Florida Limited Liability Company Act (Chapter 608 of the Florida Statutes, which is sometimes hereinafter referred to as "the Act") and any applicable laws of the State of Florida.

The Limited Liability Company shall have all of the powers vested in a limited liability company organized and existing by virtue of such laws.

**ARTICLE V**  
**MEMBERS**

This Limited Liability Company shall initially be a single member LLC. The names and address of its sole member is:

The Limited Liability Company reserves the right to add additional members and/or member managers in the future on the prior unanimous written agreements of the then existing members, or as otherwise provided in the Operating Agreement.

**ARTICLE VI**  
**MANAGEMENT**

The overall management and control of the business and affairs of the Limited Liability Company shall be vested in its members, as provided in these Articles of Organizations and Section 608.407 (or any successor section) of the Act. Any and all action by the Limited Liability Company shall require the vote of members holding a majority interest in the Limited Liability Company.

Initially, the Limited Liability Company shall be managed by its single member, Jody Swain, as designated in Article V above.

The Limited Liability Company may also designate persons to be advisors to the Limited Liability Company. The advisors, if so designated, shall act as advisors to the member manager(s) only and shall have no decision making power or authority to bind the Limited Liability Company, unless otherwise and specifically designated in writing.

**ARTICLE VII**  
**CAPITAL CONTRIBUTIONS**

Contributions to the capital of the Limited Liability Company shall be made by the members, in the manner prescribed by the written Operating Agreement made and entered into by the members and which may be amended from time to time in accordance with its terms.

**ARTICLE VIII**  
**REGISTERED AGENT**

The address of the initial Registered Office is 116 South Park Avenue, Sanford, FL 32771 (physical address), P.O. Box 950880, Lake Mary, FL 32795-0880 (mailing address). The initial Registered Agent at such address is Law Offices of James M. Miller.

**ARTICLE IX**  
**EFFECTIVE DATE**

The effective date of the Limited Liability Company shall be upon the filing of these Articles of Organization by the Division of Corporations, Department of State, State of Florida.

**ARTICLE X**  
**CONTINUITY OF BUSINESS**

On the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member, or on the occurrence of any other event that terminates the continued membership of a member in the Limited Liability Company, or upon any other event that under the Act, would result in dissolution of the Limited Liability Company, the business of the Limited Liability Company may be continued and the Limited Liability Company will not be dissolved without the prior written consent of all the remaining members of the Limited Liability Company, if any.

**ARTICLE XI**  
**INDEMNIFICATION**

Except as expressly provided in the Operating Agreement, the Limited Liability Company shall indemnify any member, manager, or former member or manager to the full extent permitted under the Act.

**ARTICLE XII**  
**SOLE MEMBER TO SIGN ORGANIZATION DOCUMENTS**

As the sole member, Jody Swain, is authorized to sign the organizing documents of the Limited Liability Company.
