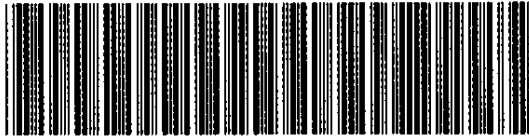

The undersigned, being authorized to execute and file these Articles of Organization, hereby certifies that:

ARTICLE I - Name:

The name of the limited liability company (hereinafter referred to as the "Company") is JMG Capital Holdings 2, LLC.

ARTICLE II - Address:

ARTICLE VII - Existence of Company:


The existence of the Company shall commence on the date these Articles of Organization are filed with the Florida Department of State.
