**ARTICLES OF ORGANIZATION
FOR

The undersigned, acting as the organizer of Morgan Whitewood, LLC under the Florida Limited Liability Company Act, Chapter 608, Fla. Stat., adopts the following Articles of Organization:

**ARTICLE I
NAME**
