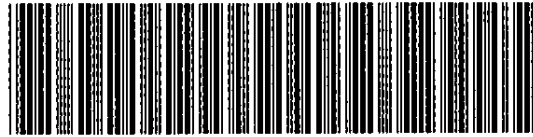

**ARTICLES OF ORGANIZATION  
OF  
GULL COVE PROPERTIES, LLC,  
a Florida Limited Liability Company**

The undersigned, being the duly authorized representative of the initial members of a limited liability company to be organized under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, adopts and submits the following Articles of Organization for such limited liability company:

**ARTICLE I  
NAME**

The name of the limited liability company is **GULL COVE PROPERTIES, LLC**, a Florida limited liability company (the "Company").

**ARTICLE II  
PRINCIPAL PLACE OF BUSINESS**

The mailing address and street address of the principal office of the Company shall be **568 9<sup>th</sup> St. South #131, Naples, Florida 34102-6620**.

**ARTICLE III  
REGISTERED OFFICE AND REGISTERED AGENT**

ADMISSION OF MEMBERS**

DURATION**

Upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member, or any other event that would terminate the continued membership of a member in the Company, the remaining members shall have the right to continue the business of the Company as provided in the Operating Agreement and Regulations.

**ARTICLE VII


**ARTICLE VIII
