**ARTICLES OF ORGANIZATION
OF
134-1 ERNEST ST., LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes, Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I

NAME

The name of the limited liability company shall be 134-1 Ernest St., LLC (the "Company"). The mailing and street address of the principal office of the Company in Florida shall be 134-1 Ernest St., Jacksonville, Florida 32204.

ARTICLE II

PURPOSES AND POWERS

TERMINATION OF EXISTENCE**

The Company shall not be dissolved upon the occurrence of any event that terminates the continued membership of a member in the Company, provided there is at least one remaining member. The Company shall be terminated and dissolved upon the consent of all of the members.


**ARTICLE VI


