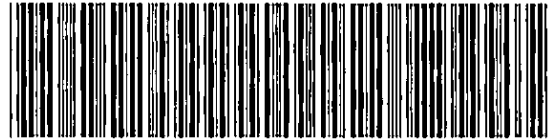

FIRST: This Amended Restated Articles of Organization amends and restates the Articles of Organization of Teacher Next Door, PLLC.

SECOND: The original Articles of Organization of Teacher Next Door, PLLC were filed with the Florida Department of State on July 5, 2013, and assigned Document Number L13000095871.

THIRD: The Articles of Organization of Teacher Next Door, PLLC are hereby amended and restated by deleting the existing Articles of Organization of Teacher Next Door, PLLC in its entirety and replacing it with the following:

The mailing address and street address of the principal office of the Company shall be as follows:


