

The Limited Liability Company shall pay such expenses, including attorney's fees, in advance of the final disposition of any such action, suit of proceeding upon receipt of an undertaking satisfactory to the Board of Managers by or on behalf of such person to repay such amount, unless it shall ultimately be determined that he or she is entitled to indemnification by the Limited Liability Company for such expense. Indemnification hereunder shall continue as to a person who has ceased to be a manager, officer, employee or agent and shall inure to the benefit of the heirs, executors and administrators of such person. The Board of Managers may authorize the purchase and maintenance of insurance on behalf of any person who is or was a manager, officer, employee, or agent of another company, partnership, limited partnership, joint venture, trust, or other enterprise against liability asserted against him or her and incurred by him or her in any such capacity or arising out of his or her status as such, whether or not the Limited Liability Company would have the power to indemnify him or her against such liability hereunder.
