**ARTICLES OF ORGANIZATION
OF

1. **NAME.** The name of this limited liability company is Van University Plaza, LLC (the "Company"), and it shall be formed as a limited liability company under Chapter 608 of the laws of the State of Florida.


2. **PLACE OF BUSINESS.** The mailing address and street address of the Company's principal office is 400 Carillon Parkway, Suite 230, St. Petersburg, Florida 33716.

4. **MANAGEMENT OF THE COMPANY.** The Company shall be managed by a manager or managers in accordance with the Operating Agreement adopted by all of the members and is, therefore, a **manager-managed** company. 
