The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Act, Florida Statutes Chapter 608, hereby makes acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be **INTERINVESTMENTS, LLC**, ("Company").

These regulations may contain any provisions for the regulations and management of the affairs of the Company not inconsistent with law of these articles of Organization. 
