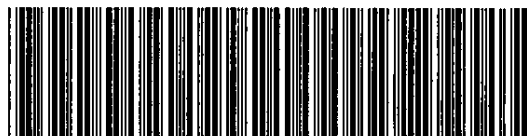

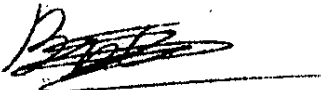
Dear Ms. Saly:
