**ARTICLES OF ORGANIZATION
OF

The undersigned hereby forms a limited liability company with the meaning of the applicable provision of Chapter 608, Florida Statutes.

**ARTICLE I
NAME**

The name of this limited liability company is SJL7 Properties, LLC (the "Company").

**ARTICLE II
DURATION**
