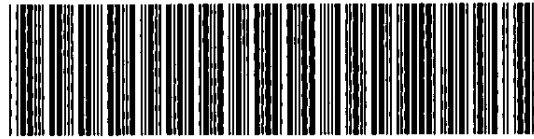

The name of the limited liability company is **Rockville Entertainment, LLC**. The Company is manager-managed.


