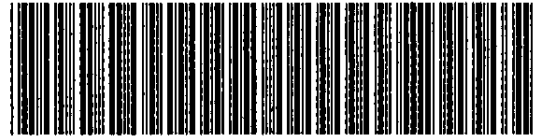

NAME**


**ARTICLE VI


