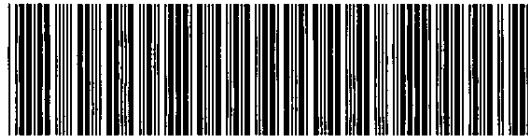

The Articles of Organization for this Limited Liability Company were filed on July 18, 2013, and assigned Florida document number L13000101908, and are hereby amended and restated as follows:

ARTICLE I
NAME

The name of the Limited Liability Company is QT1132, LLC (the "Limited Liability Company").

ARTICLE II
ADDRESSES

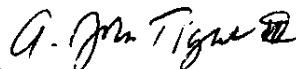
