ARTICLES OF ORGANIZATION

HEALTH FIRST PRIMARY CARE, P.L., a Florida professional limited liability company assigned document number L13000102224 (the "Limited Liability Company"), organized and existing under the Florida Revised Limited Liability Company Act and Chapter 621, Professional Service Corporations and Limited Liability Companies, of the Florida Statutes ("F.S."), does hereby certify:

A. The Limited Liability Company, pursuant to the provisions of Section 605.0202 F.S., hereby adopts these Amended and Restated Articles of Organization (the "A&R Articles"), which accurately restate, integrate and supersede the original Articles of Organization of the Limited Liability Company filed with the Department of State of the State of Florida on July 18, 2013:

B. The A&R Articles, and all amendments contained herein, were duly approved and adopted by unanimous written consent of the members and managers of the Limited Liability Company, effective as of January 15, 2021; and

C. The original Articles of Organization of the Limited Liability Company and all amendments and supplements thereto are hereby superseded by the A&R Articles, which are as follows:

**ARTICLE I.

PURPOSE**


This Limited Liability Company may engage in any activity or business permitted under the laws of the United States of America and of the State of Florida.


