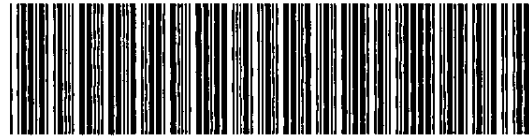



ARTICLE IV - Manager:


