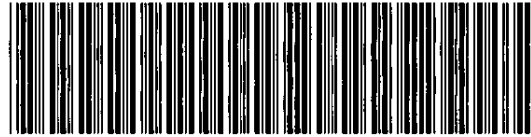

RIGHT OF CONTINUANCE**


