Articles of Organization

A Florida Limited Liability Company

- Name. The name of this limited liability company is 12601 Metro, LEC (the "Company"), and it shall be formed as a Florida limited liability company under Chapter 608, Florida Statutes.
- Duration. The Company shall exist from the date of filing of these Articles of Organization with the Florida Secretary of State, and the Company's existence shall be perpetual.
- Purpose. The Company is organized for the purpose of transacting all 3. lawful activities and businesses that may be conducted by a limited liability company under the laws of the State of Florida.
