1. Name. The name of this limited liability company is AQUA ONE, LLC (the "Company"), and it shall be formed as a limited liability company under Chapter 608 of the laws of the State of Florida.

2. Place of Principal Office. The mailing and street address of the Company's principal office is 100 Second Avenue South, Suite 302-S, St. Petersburg, Florida 33701.
