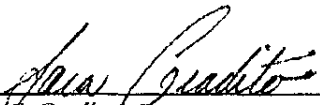

Management

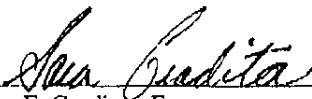
The Company shall be managed by a Manager or Managers, who may be, but need not be Members. The initial Managers of the Company are:
