ARTICLES OF ORGANIZATION

OF

TRANSFORMED TREE CARE & LANDSCAPES LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be **TRANSFORMED TREE CARE & LANDSCAPES LLC** ("Company").

ARTICLE 2 - ADDRESS

whose mailing addresses shall be the same as the principal office of the Company.

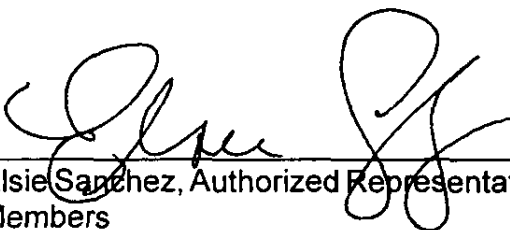

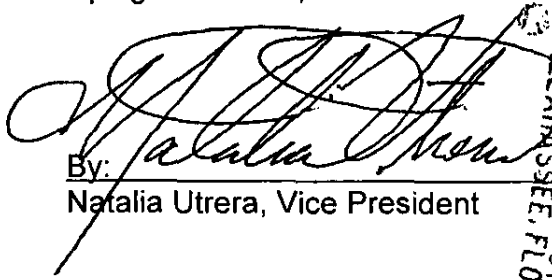
