ARTICLES OF ORGANIZATION OF ST ACADEMY, LLC

The undersigned subscriber to these Articles of Organization, a natural person competent to contract, does hereby form a limited liability company under the laws of the State Of Florida.

ARTICLE I

The name of the limited liability company shall be: ST Academy, LLC

ARTICLE (I Address and Place of Business

ARTICLE III Period of Duration

The limited liability company shall begin existence on the day of filing, and shall continue into perpetuity, or until dissolved in a manner provided by law or by regulations adopted by the Members of the limited fiability company.

ARTICLE VII Operating Agreement

The members of the limited liability company shall adopt an operating agreement which shall act as the operating agreement of the members pertaining to the regulation, management and affairs of the limited liability company, provided that such operating agreement shall not be inconsistent with these Articles of Organization or with the laws of the State of Florida. The operating agreement shall be repealed or aftered only by the members of the limited liability company, in the manner now or hereafter prescribed by the laws of the State of Florida.
