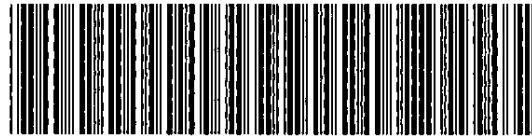


ARTICLE VIII


