ARTICLES OF ORGANIZATION

OF

ART OF SHOES AND BEYOND, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be ART OF SHOES AND BEYOND, LLC ("Company").

ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be 580 Northwest 26th Street, Miami, Florida 33127 and the mailing address shall be the same.
