# ARTICLES OF ORGANIZATION FOR JGS & MCS, LLC

The undersigned, acting as the authorized representative of the organizing Members of a Limited Liability Company to be formed under the Florida Limited Liability Company Act, as Amended (the "Act"), hereby forms a Florida Limited Liability Company (the "Company") pursuant to the Act, and hereby sets forth the following Articles of Organization (the "Articles"):

#### ARTICLE I

#### Name

The Name of the Company is JGS & MCS, LLC, a Florida limited liability company.

#### ARTICLE II

#### Commencement Date and Duration

The Company's existence shall commence upon filing these Articles with the Florida Department of State, and shall continue perpetually unless dissolved in accordance with Section 608.441 of the Florida Statutes.

#### ARTICLE III

#### Purpose

The Company is created to conduct any lawful business under the laws of the State of Florida.

#### ARTICLE IV

#### **Principal Office**

#### ARTICLE V

#### Registered Agent and Office

The initial registered agent for the Company for service of process shall be Joshua Gary Sankes, and the address of the registered agent shall be 7795 Holiday Drive N, Sarasota, FL 34231.

#### ARTICLE VI

#### Management of Business

The Company shall be managed by its Members. The initial Members of the Company are Joshua Gary Sankes and Matthew Clint Sankes.

#### ARTICLE VII

#### Admission of Additional Members

Additional Members may be admitted only by the unanimous vote or consent of all current Members, upon terms and conditions established by the Members from time to time in their sole discretion.

#### ARTICLE VIII

#### Powers

The Company shall have all of the powers and authority set forth in Section 608.404 of the <u>Florida Statutes</u>, as limited by these Articles of Organization and the Operating Agreement.

#### ARTICLE IX

#### **Property**

- (a) <u>Ownership</u>. All funds paid to the Company as contributions to capital by the Members, and all property acquired by the Company by purchase or otherwise, shall be the property of the Company.
- (b) <u>Title.</u> The title to all property of the Company shall be held in the name of the Company.

## ARTICLE XI Operating Agreement

An Operating Agreement shall be prepared and adopted to govern the internal affairs of the Company containing such provisions as may be necessary, reasonable, or desirable, except that no provision of such Operating Agreement may conflict with the provisions of these Articles. The power to adopt, alter, amend, or repeal the Operating Agreement shall be set forth therein.
