





**ARTICLES OF ORGANIZATION
OF

The undersigned, for the purpose of forming a limited liability company under the laws of Florida, hereby adopts the following Articles of Organization:

ARTICLE I

NAME

The name of the limited liability company is SKENES ENTERPRISES, LLC.

membership of a member in the limited liability company, provided each remaining member consents thereto in writing.




