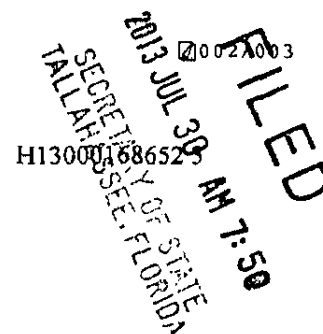


**ARTICLES OF ORGANIZATION


