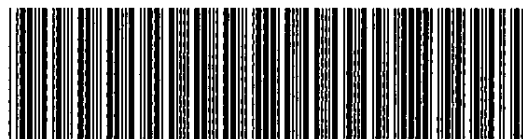

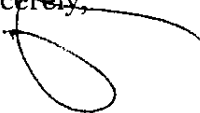

1. **ARTICLES OF ORGANIZATION (PURSUANT TO CHAPTER 608).**

ARTICLE I
NAME

The name of the Limited Liability Company is as follows:
